

Guatemala, February 1, 2025

Dear Sirs:

As of today, 284 days have passed without seeing my daughters, talking to them on the phone or knowing how they are doing. I have been banned by my husband from being part of their lives. I was not able to see them for Christmas, Alejandra's birthday, New Year's Eve, or even school activities. I couldn't spend time with them, talk to them on the phone, send them text messages or contact them in any form or manner. Time can't be turned back, there is no money to make up for it. Are you fathers or mothers, what would you do in my situation?

As I mentioned before, I was granted a constitutional motion "amparo", ordering an illegal resolution to be revoked, reinstating my constitutional right to free speech. A second constitutional motion "amparo", was also granted, restituting my rights as a mother, as I have let you know in one of my previous letters. Now the Public Prosecutor's Office, after conducting its investigation, requested the judge to dismiss the complaint filed against me by my husband. The case is being dismissed simply because there is no basis for it. As I said before, this is part of the abuse that I have been subjected to by my husband, with the money of Peppertree, Goldman Sachs, and with the help of Adam Schachter.

All these actions have been nothing but a way to use violence against me, as a woman, a woman protected by the law in Guatemala. All these acts were funded by Peppertree and Goldman Sachs, with the help of Adam Schachter. I have written to Mr. Schachter, but he never answers my letters. I know that he has been helping my husband from the start. I wonder why. Was he promised a considerable a substantial sum of money when the arbitration is over, and an award in Peppertrees' favor is passed, as my husband was?

Jorge Gaitan has committed some of these acts to gag me, silence me, so that I won't make you aware of all the lies and abuses he has committed against me and others so you may continue to think that he is an innocent man, a victim. Can't you see that he has been charged with all these crimes in Guatemala and El Salvador? Do you give more credit to social media content than Court Orders from Judges in Guatemala and El Salvador? If so, how do you justify it?


For me this process has been very painful and letting all of you know about the abuse my husband has subjected me to, has been difficult too. But above all, I need you to understand that your actions, paying for his legal defense in personal matters, are not only affecting me, but my daughters. Do you think that a good father, a good catholic, someone with moral values, would allow for his daughters not to see or communicate with their mother for 284 days? He is punishing me for not being his accomplice.

Please, all of you, stop helping Jorge Gaitán and allowing him to receive unlimited funds (as he said), without any accountability. You may be participating indirectly in his actions, and you could be held responsible.

I have demanded answers, but nobody responds to my letters, not even the compliance officers who have an obligation to investigate. If there is no wrongdoing, why haven't they answered my letters and my emails?
